Practitioners of acupuncture and Chinese herbal medicine are now regulated by the Chinese Medicine Board of Australia (CMBA), which in turn operates under auspices of the Australian Health Practitioner Regulatory Agency (AHPRA). Programs of study in leading to a qualification in acupuncture and/or Chinese herbal medicine are also subject to oversight and accreditation by the CMBA.

Keynote and invited speakers are being drawn from diverse sources to ensure a broad range of clinically relevant topics to interest practitioners, researchers, educators and regulators. Key issues in clinical practice, research methodology, education and practice standards, quality assurance and safety, policy formulation and regulation will be discussed and debated. In addition to a panel of exceptional keynote and invited speakers, AACMA invites international acupuncture and Chinese medicine practitioners to submit abstracts for oral presentations, workshops and poster presentation. General information on submitting an abstract is included with this Announcement, with more detailed directions and guidelines provided on the conference website.

WFAS 2013 offers immense scope for professional development and will provide a unique opportunity to network with colleagues and friends from all corners of the globe. Furthermore, the intellectual stimulus that you can expect from this Conference will, we hope, be balanced with your enjoyment of the outstanding and breathtaking beauty of Sydney harbour and the surrounding region. We are pleased to see that more and more people are looking for alternative, natural, and safe treatments for their health. Acupuncture, a demonstratively safe, effective, and costeffect therapy, has been increasingly integrated into mainstream healthcare and is now widely accepted in many countries. ABSTRACT SUBMISSION

submitted Abstracts must he electronically via the on-line Abstract Submission Portal, found at www.wfas2013sydney.com.

DEADLINE FOR SUBMISSION

The deadline for abstract submission is 31 March 2013. Late submissions may be considered at the sole discretion of the Organising Committee.

ABSTRACT LANGUAGE

Abstracts MUST be typed in English in MS Word format using Times New Roman 12 point font using the on-line form.

Abstracts may ALSO be submitted in Chinese in Word format using Simsun font using the Chinese language abstract form - COMING SOON!

PRESENTATION LANGUAGE

The conference languages are English and Chinese (Mandarin). Simultaneous English-Chinese and Chinese-English translation will be provided for selected sessions. Some sessions may be in English only. If you wish to present in a language other than Chinese or English, you will need to prepare your powerpoint in English. Please indicate the presentation language when prompted on the online abstract form. Posters may be in any language but MUST include a full translation into English.

PRESENTER INFORMATION

Personal details of the person presenting the paper must be completed. The presenter must register for the conference and pay the delegate fee before, or at the time of, submitting the abstract. An abstract will not be accepted if the presenter has not registered for the conference.

TITLE OF PRESENTATION

To be typed in Sentence case (First word initial Capital, capitals only for ACRONYMS and first letter of a Proper Noun).

ABSTRACT FORMAT

The abstract is to be uploaded via the on-line portal as an MS Word document. The text of the abstract must be typed in English in Times New Roman 12 point, single line-spacing, and should not exceed 250 words. Abstracts in Chinese should be submitted in Word format using Simsun font together with an accurate translation into English. All acu-points and meridians must be named according to Standard Acupuncture Point Locations (World Health Organization Western Pacific Regional Office, 2008) or Standard Acupuncture Nomenclature, Parts 1 & 2 (WHO, 1991: revised edition).

CONTENT OF ABSTRACTS

For abstracts of reports on research, including clinical trials, the following should be included: General description/ Objectives; Methods; Results; Conclusion/ Commentary. Other abstracts should clearly indicate the structure of the proposed presentation.

PRESENTER BIOGRAPHY

A short biography of the presenter needs to be submitted on the abstract form (maximum 75 words).

AV REQUIREMENTS

The following resources will be available for oral presentations and workshops: laptop with MS PowerPoint software, data projector and screen, laser pointer. If a film slide, DVD or video presentation is proposed, this must be specified under AV requirements when prompted on the online abstract form. Videos must be VHS compatible. The duration of oral presentations will be 15-30 minutes, depending on the program. Practical workshops are usually a maximum of 1.5 hours. Presenters will be notified of the likely duration of their presentation by 31 July 2013.

POSTER PRESENTATIONS

Poster presentations will be displayed in a dedicated section of the conference area. Individual poster sizes must not exceed 90cm in width and 120 cm in height.

PEER REVIEW PROCESS

All abstracts will be subject to review by the WFAS 2013 Academic Committee.

Travel & Visa

GETTING TO SYDNEY

There's easy access to Sydney with over 40 international airlines providing non-stop or one-stop services to and from Australia. Sydney Airport is Australia's major gateway.

TRAVEL SECURITY

The Australian Government's travel security website TravelSECURE, is an online resource which provides information on the security measures in place at Australian airports. Its purpose is to help travellers prepare for their journey and clear the security checks at the airport quickly and easily.

VISA REQUIREMENTS

A visa is required for all travel to Australia.

Persons holding Australian an passport do not require a visa for travel to Australia. New Zealand passport holders can obtain their visa on arrival in Australia. All other passport holders must obtain an appropriate visa prior to undertaking travel to Australia.

The type of visa required depends on the purpose of the visit. If the purpose is to attend a conference, meeting or seminar, then you should apply for a business visitor visa. Accompanying persons not attending the conference should apply for a tourist visa.

For detailed guidance, download the Australian Government information sheet on Visa Options for Business Events. A summary of the visa information is included below.

VISA OPTIONS - ONLINE APPLICATIONS

eVisitor (Subclass 651)

This is an electronically stored authority for visits to Australia for tourism or business purposes for up to three months. An online eVisitor visa is available to passport holders from the European Union and a number of other European countries who are outside Australia. Accompanying persons should separately apply for an eVisitor (Tourist stream). http://www.immi.gov.au/visitors/tourist/evisitor/.

ETA (Business Entrant) (Subclass 977)

This is an Electronic Travel Authority (ETA) for short-term visits to Australia of up to 3 months and is available to passport holders from a number of countries. http://www.immi.gov.au/skilled/business/956-977/

To be eligible to apply for an ETA, you must:

- · be outside Australia
- hold an ETA eligible passport.

ETA eligible passports

If you hold a passport issued by one of the countries listed below, you can apply for an ETA through your travel agent, airline, specialist service provider or an Australian visa office.

Holders of Taiwan passports in Taiwan can apply through an approved ETA travel agent in Taiwan. Holders of Taiwan passports outside Taiwan can apply for an ETA at their closest Australian visa office.

Accompanying persons not attending the conference should apply for an ETA (Visitor) (Sub-calll 976).

All other passport holders need to submit a paper-based application to your local Australian visa office for a Business (Short Stav) visa (Subclass 456). Delegates applying via the paperbased visa application process will require a letter of invitation from the conference organiser, AACMA. Under normal circumstances, the original of the letter of invitation must be submitted with the visa, otherwise you may be refused a visa.

Applicants should allow 6 – 8 weeks for visa processing.

Letter of invitation for visa purposes

The following conditions will need to be met before a letter of invitation can be issued:

- · register as a delegate for the conference and pay the delegate fee in full and
- · complete the Passport Details section of the Registration Form

Letters of invitation are issued at the sole discretion of the conference organiser, AACMA. A decision by AACMA to issue or refuse a letter of invitation in each instance is final. There is no refund of the conference registration delegate fee once a letter of invitation has been issued.
